PUBLICATION OF UP-TO-DATE REGISTER FOR ALLIED HEALTH PROFESSIONALS IN THE UGANDA GAZETTE

Section 24(2) of the Act provides that, "The Registrar shall cause to be published in the *Gazette* the name of a person registered or struck off the register as soon as is practicable and shall, after the 1st day of January and not later than 31st day of March in each year, cause to be published in the *Gazette* the up-to-date register maintained under this section."

ACCORDINGLY, NOTICE IS HEREBY GIVEN to all allied health professionals and their employers that following Council's public notice No. 01/2012-2013 of

6th August 2012 in *New Vision* accompanied with the numerous reminders on registration and the renewal of practicing license requirements for all practitioners, **30th November 2013** has been set as the deadline for updating individual registration details for all professionals on the register.

The following categories of professionals shall be published in the *Uganda Gazette* on the **2nd day of January 2014**;

a) Professionals registered in 2012 and below with

a valid annual practicing license (APL) of 2013
b) Professionals registered in 2013.

Therefore, any person whose name shall not appear in the gazette shall be deemed an illegal practitioner. The attention of all allied health professionals, employers and the general public is accordingly drawn to section 50(1(a&c)) of the Act on publication prima facie evidence.
